Competition Rules

- British Show Jumping membership cards must be produced at collecting ring at time of declaration
- Entries in all classes confined to registered horses to be ridden by members in accordance with British Show Jumping rule 79.
- Competitors must jump in declared or catalogue order.
- Competitor numbers must be worn in the ring at all times.
- All prize winners must be mounted and wearing numbers
- Junior members competing on horses are only able to do so from the beginning of the calendar year in which the age of 12 is reached
- ***Horse & rider membership numbers MUST be shown at time of declaration. Prize money can be withheld.***

HEALTH AND SAFETY

The Organisers of this show have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the Organisers and all the Officials and Stewards.

HORSE WALKS

To comply with Health and Safety Executive guidelines the Society has created horse walks. It is a condition of entry that all exhibits keep within these designated routes that all reasonable precautions are taken to prevent accidents and that guidance is taken from Officials or Stewards at crossing points etc.

SAFETY HEADGEAR

Anyone on a horse or pony **MUST WEAR A SKULL CAP OR HARD HAT** to the current approved BSI or European Standard with the chinstrap fastened securely at all times.

TERMS & CONDITIONS

GENERAL

ALL SHOW JUMPING COMPETITORS must comply with the Showground Regulations & PAS Animal Welfare Plan.

1. DATE & LOCATION OF SHOW

The Show will be held on 15th – 17th August 2017 at the County Showground, Withybush, Haverfordwest, Pembrokeshire, SA62 4BW.

2. PUBLIC PRICE OF ADMISSION

Gate prices: Adult £19.00; Senior £17.00; Junior £6.00; Super Saver £20.00; Family Saver £39.00. Please see www.pembsshow.org for pre-show ticket offers.

3. SOCIETY MEMBERSHIP

Details of membership for the Society are available from the website www.pembsshow.org. 2017 Membership applications close on 30th June 2017.

4. EXHIBITOR ACCOMMODATION

Caravan passes for either the Exhibitors Caravan Park or within Horse Lines can be purchased at the time of entry at a rate of £45.00 (inc VAT). N.B. Electric hook ups are not available. Shower and toilet facilities are located within the Caravan Park & in the Horse Lines.

5. PUBLIC CATERING

The Stockmans Café located opposite the Livestock Building will offer a dining facility for all exhibitors for breakfast, lunch & supper and will be open from 7.00am to 8.30pm.
The Public Restaurant is located on Main Avenue next to the Members' Pavilion offering hot and cold meals and drinks. Open from 12 noon.

6. ENTRY FEES

All entries for the Society's Shows shall be made upon the Society's Official Entry Form. It shall be deposited with the Show Organiser **not later than the closing date for entries** as specified in the Show Schedules and shall, in every case, be accompanied by the full amount of the appropriate entry fees.

Every Exhibitor shall sign the Declaration printed on the Entry Form:

"I declare the above entries are, in every particular, true and correct, and I agree to prove the correctness of any such entry if called upon to do so by the Committee".

Entries can be made by **POST** using the entry form provided in the schedule or downloadable from the website or **ONLINE** at www.pembsshow.org. All entry fees are inclusive of 20% VAT. Payment is accepted via credit/debit card or by cheque made payable to PAS. All classes are subject to the entry fees outlined in the tables below, unless otherwise stated.

CLOSING DATE FOR ALL ENTRIES IS FRIDAY, 28th JULY 2017. LATE ENTRIES WILL NOT BE ACCEPTED.

7. CANCELLATION OF CLASSES and/or ENTRIES

The Pembrokeshire Agricultural Society reserves the right to refuse any entry and cancel or amalgamate class or section if it deems fit. Exhibitors already entered will be offered entry into an alternative section where appropriate or the entry fee may be returned to each exhibitor after the show.

8. SUBSTITUTION

Except in the case of Show Jumping classes, no substitution or entries will be permitted on any section of the Show after the closing date of entries. This will be at the discretion of the Showjumping Committee.

9. PRIZE MONEY

Prize money vouchers will be issued by the stewards at the same time the rosettes are awarded. The Prize Money vouchers can be redeemed for the relevant prize money at the Prize Money Office located opposite the President's Pavilion on Main Avenue during the Show Period. The Prize Money Office opening hours are 10.30am – 5.00pm each day. Any prize money **NOT** collected from the Prize Money Office during the Show Period will be issued via cheque only from the Show Office on receipt of the Prize Money Vouchers (*not Prize Cards*) by 30 September 2017.

10. AWARDS & PRESENTATIONS

Prize money and rosettes will be awarded in accordance with the information set out for each show jumping competition in schedule. The Society reserves the right to withdraw or add prize money as deemed fit or the conditions of the competition allow them to do so.

12. ADMISSION TICKET/WRISTBAND & VEHICLE PASS ENTITLEMENT

All exhibitors are issued with admission tickets or wristbands and vehicle passes based on the number of animals entered and days attending the show. This is set out in the information specific to each section. Additional wristbands can be purchased at the time of entry at the following rates: *Exhibitor tickets £17.00 per wristband per day (inc VAT); Additional Horse Vehicle pass £32.00 (inc VAT)*. **Exhibitors are requested to check all tickets and passes on receipt.** Only vehicles carrying livestock or horses and clearly displaying the relevant vehicle pass on the windscreen will be admitted at the relevant gates. Any person entering the site on Show days including the drivers of stock lorries, horseboxes or trailers must have a valid admission ticket or wristband or they will be expected to pay the full admission price at the gate. The Show will not take any responsibility for any tickets or passes that have been mislaid or forgotten.

13. STEWARDS

No Steward or other official of the Show, whilst in charge of any animal competing in the Show, shall wear any official rosette or ribbon when he enters the Judging Ring.

14. DRESS CODE

All exhibitors/handlers should ensure they are wearing the correct show clothing and footwear required to enter the designated show rings and the Grand Parades.

15. PUBLIC LIABILITY

All exhibitors must have public/third party insurance.

16. HEALTH AND SAFETY

The Organisers of this show have taken reasonable precautions to ensure the health and safety of everyone present. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents occurring and must obey the instructions of the Organisers and all the Officials and Stewards. Please ensure that all animals are show trained and that all show equipment is in good condition.

It is the exhibitors' responsibility to provide livestock and equine attendants and equipment necessary to control their livestock and horses & ponies at all times whilst on the Showground.

17. ANIMAL WELFARE

GENERAL CONDITIONS FOR SHOW JUMPING COMPETITORS

SHOWJUMPING COMPETITIONS WILL BE HELD ON TUESDAY, 15th, WEDNESDAY, 16th & THURSDAY, 17th AUGUST

1. ARRIVAL & DEPARTURE OF COMPETITION HORSES & PONIES

Please use Gate 4 (GREY) Horse Entrance for all showjumping competitors. ***The arrival of horses and ponies is permitted from 2.30pm on Monday, 14th August.*** Access will be restricted and limited to vehicles displaying a Horse Vehicle pass and their occupants holding the correct wristbands or admission ticket(s).

2. STABLE ACCOMMODATION & FACILITIES

Permanent and temporary stable accommodation is available for the duration of the show. Stables are available to reserve from 7pm until 6.30pm the following day with the exception of Monday when they are available from 2.30pm. ***You must state clearly on your entry form on which day you require stabling. Please also note if stabling is required for a stallion.***

Competitors requiring stabling through the day ***only*** will still have to book the stable for the previous night. All competitors must vacate stables by 6.30pm daily in order to prepare for the following exhibitor.

The Stable Manager or a Stable Assistant will be on site:

Monday	2.30pm – 10.00pm	Tuesday	6.30am – 10.00pm
Wednesday	6.30am – 10.00pm	Thursday	6.30am – 4.00pm

Stables booked for three consecutive nights by Showjumping competitors will be charged at £85.00 (£20.00 discount off the full rate of £105.00)

3. STABLE BEDDING

A single bale of straw will be allocated to each stable per day. Additional bedding must be provided by the exhibitor. ***Exhibitors must ensure stables have been cleared of all soiled bedding before departure if not booked for 3 nights. (a charge of £10 will be made if the boxes are not cleared of soiled bedding if only booked for Monday and/or Tuesday nights).***

4. HORSE PASSPORTS & BREED REGISTRATION

The Equine Identification (Wales) Regulations 2009 require all horse owners to obtain a passport for each animal that they own. Horse exhibitors should ensure that they are in receipt of the necessary passports for all horses and/or ponies they are exhibiting at the show and have them available for inspection if asked by the Local Trading Standards officers.

It is the responsibility of the exhibitor to ensure that all horses and ponies they are entering are registered with the necessary breed society or organisation prior to the show. Registration numbers must be quoted on the entry form.

5. SAFETY HEADGEAR

Anyone on a horse or pony ***MUST WEAR A SKULL CAP OR HARD HAT*** to the current approved BSI or European Standard with the chinstrap fastened securely at all times. (BS Rule 101.3)

6. HEALTH & SAFETY IN THE HORSE WALK

Access to the Horse Walk is by horse exhibitor wristband only and for the purpose of going to and from the Grand Arena, Horse Arena or the Showjumping Arena with exhibits. Any person without a wristband will not be permitted to access the Horse Walk at any time. In the interest of safety, pedestrian crossings of the Horse Walk will be manned by crossing stewards. At no point will the general public be permitted to cross the Horse Walk whilst equines are within the Horse Walk.

7. ENTRY FEES & PRIZE MONEY

Entry fees and prize money can be found at the end of each class.

Compulsory First Aid is payable at £4.00 per horse for the duration of the Show.

8. ADMISSION TICKET/WRISTBAND & VEHICLE PASS ENTITLEMENT

Please note the ticket allocation will be based on ***each of the owners*** noted on the entry forms.

In the event of insufficient starters lower prizes may be withheld in accordance with British Showjumping Rule 76.6 in all classes.

BY-LAWS RELATING TO THE HOLDING OF THE SOCIETY'S SHOWS

1. All Members whose subscriptions are not paid in advance shall be ineligible for any prize or prizes offered by the Society (subject to By-Law No2)
2. No person shall compete in the County Show unless he is a member, except in such classes as the Show Council deem it advisable to throw open and, in these, non-members shall pay at least double entry fee. The Show Council reserves the right to refuse any entry.
3. All stock shown in competition must be bona fide the property of the exhibitor at the time.
4. The entry fee for all classes shall be at the discretion of the Show Council, to be agreed annually.
5. The Show Council shall appoint competent judges to award the prizes. The judge may call in a veterinary surgeon if required.
6. Members shall be admitted to the Showground free; non-members as settled annually in committee.

ENTRIES

7. All entries for the Society's shows shall be made upon the Society's official entry form. This shall be deposited with the Show Organiser not later than the closing date for entries specified in the Show's schedules and shall, in every case, be accompanied by the full amount of the appropriate entry fees. Every exhibitor shall sign the following Declaration, which shall be printed on the entry form: "I/We hereby agree that the particulars stated are correct to the best of my knowledge and belief and I/We agree to conform to the rules and regulations for the Society which are laid out in the Schedule. I/We confirm I/We have my/our own Public Liability insurance". Wherever, in accordance with a class definition or regulation, e.g. a mare is to be shown "with foal at foot" this Declaration shall be deemed to certify that the foal shown **IS** the foal of the mare with which it is shown.

SUBSTITUTION

8. Except in the case of Show Jumping classes (BS Rule 79.4), no substitution or entries will be permitted on any section of the Show after the closing date of entries.
9. In every agricultural class (i.e. Cattle, Pigs, Sheep, Horses and Ponies) three prizes shall be offered. But it shall be lawful for the Show Council to add further prizes as they may from time to time deem desirable, and to relate the award of such additional prizes to the number of entries as they think fit. The prize may be withheld if, in the opinion of the Judge or Judges, the exhibit is unworthy or of insufficient merit.
10. No steward or other official of the Show, whilst in charge of any animal competing in the Show, shall wear any rosette or ribbon when he enters the judging ring.

PARADE OF PRIZEWINNERS

11. During the afternoon of each day of the Show, time permitting and at the time to be specified in the Show time table of events, there will be a parade of prize winning animals. Any exhibitor failing to bring his prize-winning exhibits into the appropriate Parade shall be liable, at the discretion of the Show Council, to forfeit any prizes awarded to such exhibits.
12. All exhibits and all persons in charge of the same will be subject to the Orders, Regulations and Rules of the Society and the Stewards shall have the power to remove from the Showground the stock or property belonging to, and to cancel the admission ticket of any exhibitor who shall infringe any of the Regulations and Conditions of the Show, or who shall refuse to comply with any instructions given by the Stewards, without any responsibility attaching to the Stewards, or the Society in consequence of such removal.

OBJECTIONS

13. Any objections to any entry receiving any award must be made in writing to the Show Organiser with the least possible delay and, within 48 hours of 6 pm on the day on which the relevant Class has been judged. Any other dispute shall, similarly, be reported to the Show Organiser, and it shall be the duty of any Steward who sees, knows of, or has good ground to suspect any irregularity to report the same to the Show Organiser forthwith. Any objections made by or on behalf of an exhibit shall be accompanied by a deposit of £20, or such other amount as the Objections Committee shall from time to time determine, which shall be returned if the objection is considered to have been justified (even if not upheld) but otherwise shall be disposed of at the discretion of the Show Council.
14. All such objections, reports, disputes and allegations or irregularities affecting any entry shall be referred to Objections Committee whose decision shall be final and binding on all concerned.
15. If, upon the hearing of any objection or other matter within the last rule, it shall appear to the satisfaction of those by whom it is determined that there has been a false statement as to age, ownership, identity or other material particular shall forfeit any awards in respect of the animal shall be disqualified and its owner

shall decide that such irregularity has not materially affected the awards and has not been deliberately made. But if the Objections Committee shall conclude that the false statement has been deliberately made (as to which their decision shall be final and binding). All animals entered by the exhibitor concerned shall be disqualified from receiving any prize or award at the Show.

16. In the case of any prize animal being disqualified, the winner of the next prize in that class shall take that prize, and so on throughout the class; and the lower prize in that class shall go to the next in merit, a list of which the Judge shall be instructed to deliver in every class.

17. The Society, the Show Council, its officers or servants, shall not be responsible to any persons, whatsoever while upon the Society's premises, or while entering or leaving the same, for any damage or loss however caused to the property of any such person.

18. LIABILITY

(1) (a) In the By-Law the term "exhibitor" shall include persons taking part in any event, competition or display promoted or arranged by the Society and the owner of any exhibit, animal, plant, vehicle, equipment, machinery, article or other thing of whatever nature involved in any such event, competition or display or otherwise exhibited or used on the Showground or elsewhere.

(b) Save for death or personal injury caused by the negligence of the Society, its servants or agents, the Society will not be responsible for death, injury, disease, damage or loss caused to any exhibitor or to his or her servants or agents or to any exhibit, animal, loss caused to any exhibitor or to his or her servants or agents or to any exhibit, animal, vehicle, equipment, plant, machinery, article or thing of whatever nature brought onto the Showground by the exhibitor or involved in any said event, competition or display.

(c) Save as aforesaid, the exhibitor shall indemnify the Society against all claims, losses, damages and expenses whatsoever in any way arising out of the presence of or the taking part of the exhibitor, his or her servants, agents, exhibits, animals, plant, vehicle, equipment, machinery, articles or other things of whatever nature on the Showground or elsewhere and shall assume full responsibility therefore.

(d) Acceptance of this By-Law shall be a condition of entry or participation in any event, competition or display, promoted or arranged by the Society.

(e) The Society accepts no responsibility or liability whatsoever for any statement or information in any document published by the Society or the Show.

(2) The Society will in no case accept liability for any loss or damage (whether direct or indirect) arising from or caused by the abandonment or cancellation whether total or partial, or the postponement of any show, display, event, meeting or other happening on the showground or elsewhere for whatever reason.

It is therefore recommended that the exhibitor should arrange appropriate insurance cover.

DATES

19. The dates for the Annual County Show shall be set by the Show Council.

ALTERATION OF BYE LAW 20. These Bye Laws may be added to, repealed or amended, by the Trustees acting on recommendations from the Council.

HEALTH & SAFETY ACT 1974

SAFETY POLICY STATEMENT

By its nature an Agricultural Show presents a potentially hazardous environment. All persons concerned in the presentation of the Show need to be vigilant and ensure that any perceived hazard is, if possible, dealt with immediately and reported to the Show Organiser in order that the necessary action can be taken.

Any incidents or near misses must be reported. In this manner it is aimed to provide a safe and healthy environment for all persons attending the Show in whatever capacity, whether as officials, contractors, exhibitors, traders, performers or members of the public.

This must be seen as an on-going commitment in which all are involved. In particular, Section Organisers and Chief Stewards must be satisfied that their Stewards have the training and experience to carry out any task allotted to them.

The Show Organiser will be responsible for issuing copies of the Safety Policy Statement to all show stewards and officials. The Show Organiser will ensure adequate provision of medical and first aid services through a nominated contract who will be responsible for maintaining accident records and where appropriate report to the Health & Safety Executive. Plans of the Showground will be held in the Show Office.

Potentially many hazards will arise from the activities of contractors. Only professional and appropriately qualified and/or experienced contractors shall be engaged for general showground work, electrical supply and maintenance, tentage, catering and course building. All contractors must undertake to have sufficient experienced staff on site to deal with emergencies on Show Days and to have sufficient insurance cover.

- (a) The Show Organiser will advise all contractors that they must observe the Health and Safety at work standards appropriate to their trades, both in terms of equipment and in handling and storage.
- (b) The Show Organiser will advise all individuals and organisations attending the show similarly and where any of their activities on the Showground give rise to potential hazards, e.g. demonstrations of machinery, they must provide any necessary barriers and or attendants to ensure public safety.
- (c) Any operator of fairground or similar equipment that needs safety certification must certify to the Show Secretary that a valid certificate exists.
- (d) The Show Organiser will advise all exhibitors of horses that only designated parking and exercise areas and walkways may be used.
- (e) The Show Organiser will advise all exhibitors of cattle, sheep or pigs as appropriate that the designated unloading areas and pens must be used and that competent adult handlers must be present.
- (f) The Dog Section Chief Steward will advise all exhibitors that all dogs must be kept on leads unless secured away from the public or under direction of a Show Steward.

The Show Organiser will plan the site layout paying particular attention to the designation of parking, unloading and penning arrangements for livestock to comply with current animal health legislation.

In addition to Red Cross medical service, Police and veterinary surgeons will be on site during build up and on Show Days.

In the event of a major incident the Chief Executive and/or Show Organiser must be informed without delay. The appropriate emergency service will be contacted and the Show Emergency Plan initiated. The objective is to protect the Public, contain the incident and minimise the consequence, (**SEE STEWARDS GUIDANCE NOTES**). Gate Stewards must be ready at any time to control incoming traffic in order to facilitate speedy

evacuation of any casualties from the Showground. In the event of a serious fire or accident all admission to the Showground will be stopped, except by the Emergency Services. Stewards will direct people to safe areas of the Showground to leave the entrance and exits clear for Emergency Services.
